Transboundary water issues are getting a growing attention by the international community and within the UN system. The adoption of the SDGs with a target on transboundary cooperation and its relevant global indicator, the entry into force at the global level of the two United Nations

conventions on transboundary water cooperation, the adoption of the UNGA resolution on the law of transboundary aquifers, the debates in the Security Council on water, peace and security and the work of the High-Level Panel on Water and Peace are driving political and technical attention on the topic.

The UN-Water Expert Group on Transboundary Waters is intended to provide a platform to:

- 1) Coordinate substantive inputs to policy processes related to transboundary waters (surface water and groundwater);
- 2) Coordinate promotion, awareness-raising and outreach efforts supporting transboundary water cooperation;
- 3) To promote coherence and coordination of activities by UN-Water members and partners in the area of transboundary waters, including on international water law, by facilitating exchange of information, experiences and lessons learned and by promoting joint efforts.
