## Water as a Driving Force for Peace and Stability

#### World Water Day 2024 is dedicated to leveraging water for peace.

Following the official launch of the UN World Water Development Report at UNESCO in Paris, this event intends to look at how water can serve as a vehicle for peace and cooperation by fostering dialogue, trust, and collaboration among different water users, in particular across national boundaries. Through concrete examples, the event will show how various countries sharing water resources may participate in dialogues, agree on water management and define institutional arrangements to maximize the benefits derived from water resources.

The event will also look into post-conflict situations, where water cooperation plays a pivotal role in rebuilding trust and fostering long-term stability, offering a tangible foundation for collaboration and mutual understanding. The event will also be an opportunity to look at the role of women in water diplomacy, and the need to increase their representation to tackle the world's water crisis and achieve lasting peace.

#### Background

# Transboundary waters account for 60 per cent of the world's freshwater flows. More than 3 billion people depend on them.


Cooperation over transboundary surface and groundwater is therefore not only essential to sustainable economic development but also to climate action, the prevention of natural hazards and the promotion of peace.

Indeed, when water is scarce or polluted, or when people struggle for access, tensions can arise. By cooperating on water, countries achieve a better balance between competing needs and thereby help stabilize situations that could otherwise quickly spiral out of control.



While there exists a number of principles, norms and institutions that provide the basis of international water cooperation, monitoring of indicator 6.5.2 shows that only 24 of 153 countries that share transboundary river, lake or aquifer basins have all their transboundary basins covered by operational arrangements.

The principle of equitable and reasonable utilization of watercourses and the obligation not to cause significant harm constitute the core around which appropriate international regimes can be developed. The right to safe drinking water and sanitation is



recognized as a moral imperative of our time and as a human right that only cooperation can guarantee in the long term.

#### The event is organized by the Transboundary Water Cooperation Coalition.

A multistakeholder partnership that has set itself the objective of highlighting the critical importance of cooperating over shared water resources at a time when climate change impacts and increasing needs threaten water supplies and quality.
