













Geneva Water Dialogue: Final Concept Note

Friday, July 1, 2022, 09:30 at the World Meteorological Organisation

Providing an input from Geneva to the UN 2023 Water Conference Exploring possible commitments to be included in the Water Action Agenda

Water is essential for human life and is linked to all SDGs. The growing water crisis, coupled with rising demand and unsustainable use of water threaten human rights, food security, livelihoods security and environmental sustainability worldwide. The UN 2023 Water Conference to be held in New York in March 2023 provides a unique opportunity for the world to come together and collectively accelerate our work to making the world a more water secure place. The two co-hosts of the Conference, the governments of Tajikistan and the Netherlands, have pledged that the Conference will be action-oriented, inclusive, and cross-sectoral. In line with this pledged inclusivity, Senegal, Egypt, Tajikistan, and the Netherlands have taken the initiative to organize the "Geneva Water Dialogue" to allow Geneva to **provide written input to the UN 2023 Water Conference** whilst at the same time encouraging Geneva-based actors to identifying commitments for a key outcome document of the Water Conference, the **Water Action Agenda**. This Agenda is a document in which stakeholders can voluntarily pledge commitments to get the world back on track to reaching SDG 6 and other water-related goals and targets.

Geneva hosts eleven of UN-Water's member organisations many of which have significant water-related mandates. Geneva and its vicinity also host many partners of UN-Water, in addition to a significant number of civil society organisations, research institutes and other stakeholders with important activities relevant to SDG 6 and other water-related goals and targets, including under the Second Water Action Decade. These Geneva actors have unique experiences and activities in promoting the achievement of these goals, targets, and indicators, mainly around the following themes: human rights, peace, and disaster risk reduction.

The first Geneva Water Dialogue is co-organized by the Permanent Missions of Egypt, Senegal, the Netherlands, and Tajikistan, with the support of WMO, UN-Water, UNDRR, OHCHR, and the Geneva Water Hub.



Objectives:

The objectives of the Geneva Water Dialogue are twofold:

First, to prepare a substantive input from Geneva to the UN 2023 Water Conference, due to take place in the UN General Assembly from 22 to 24 March 2023. This written input, to be drafted by a number of rapporteurs of the panel and workshops, will be sent to the co-hosts of the UN 2023 Water Conference as well as UNDESA and UN-Water. It will aim to:

- 1) Take stock of water-related mandates and activities of Geneva-based UN agencies, NGOs, and other organizations, and identify gaps and opportunities for enhanced coordination and coherence, and for achieving water-related goals and targets, including through the five accelerators of the SDG 6 Global Accelerator Framework.
- 2) Identify and propose concrete solutions to accelerate the achievement of SDG 6, also beyond 2030, enhance action by Geneva-based organisations with a view towards the comprehensive implementation of all SDG 6 targets and indicators, promote more coherent action and better integration of SDG 6 across the mandates of UN-Water members in Geneva.
- 3) Identify best practices that can be showcased in 2023 to be replicated by others and scaled up through financing to make an impact on a larger scale towards, and beyond, 2030.

Second, to create an opportunity for Missions, organizations, and other stakeholders to collectively brainstorm on which possible concrete **commitments** their countries or organizations may enter into, in coalitions, and based on the gaps, solutions, and best practices identified. These commitments will fill the **Water Action** Agenda, which is the agenda to be presented at the UN 2023 Water Conference to get us back on track to achieving SDG 6 and other water-related goals and targets.

10:15 – 11:45 High-level panel: Water and Human Rights

This high-level panel, with the support of **OHCHR**, will showcase ongoing efforts to address how water affects the enjoyment of all human rights, including for persons in vulnerable situations and identify gaps in this regard. It will showcase the work of Geneva-based UN organizations in a number of related areas, including the human rights to safe drinking water and sanitation; promoting universal, affordable and sustainable access to WASH; water, public health and the right to the highest attainable standard of physical and mental health. It will also address the links between effective water governance as well as clean, healthy and sustainable freshwater ecosystems and rural development, livelihoods, and human rights, including the right to food. It will also discuss cooperation for the protection of water-related human rights.

The panel will present recommendations on how to use the human rights framework to promote the comprehensive achievement of all targets and indicators of SDG 6.

Following the panel there will be room for interventions from the floor on the basis of the following **four guiding questions**:

- What efforts are underway to achieve the human right to safe drinking water and sanitation and how can we accelerate the achievement of these rights and SDG targets 6.1 and 6.2?
- How do water and clean, healthy and sustainable freshwater ecosystems impact human rights? how can the human rights framework be leveraged to accelerate the achievement of all six targets of SDG 6? What good practices exist in this regard and how can they be replicated and scaled up?
- What role can OHCHR, the Human Rights Council, the Special Procedures and the human rights community play in contributing to the achievement of SDG 6 beyond the UN 2023 Water Conference?
- How can international cooperation be advanced in this area and what kind of voluntary commitments are envisaged both at national and international levels?

13:00 - 14:30 Workshop 1: Water for Peace

Water scarcity and pollution, mismanagement of water resources as well as the lack of access to safe drinking water and sanitation is weakening already fragile states, increasing the risk of violent conflicts and sparking human displacement and migration. The first workshop, with the support of the **Geneva Water Hub**, will showcase the work being done in Geneva to address the links between the humanitarian and development sector, and how water can be a catalyst for peace. It will identify the impacts of water insecurity in humanitarian settings and highlight the existing practices to use water as a tool for development, cooperation, and lasting peace. It will furthermore address the efforts of Geneva-based humanitarian organizations to achieve SDG 6 in the spirit of leaving no one behind.

The workshop has three chief objectives:

- 1. Showcase the complementary approach of Geneva-based organization working on the humanitarian, development, and peace aspects for the achievement of SDG 6 and other water-related Goals and Targets.
- 2. Address the impacts of water insecurity, including in humanitarian settings.
- 3. Provide a fresh approach on solutions that can be provided for ensuring water as a vector for peace while making use of the SDG 6 Global Acceleration Framework.

In order to stimulate a result-oriented and interactive discussion, participants will be divided into three **smaller break-out sessions**, on the following topics:

- 1. Water in humanitarian settings: the impact of armed conflicts on access to water and sanitation & reverberating effects of damage to water resources and infrastructure
- 2. Inclusion of water resources in conflict resolution
- 3. Water cooperation, including transboundary water cooperation, as a means to sustainable peace and access to safe water and sanitation

Guiding questions for participants:

- 1. In your experience, what are the markers of success for ensuring that water is taken into due consideration in your context?
- 2. What are the accelerating measures that can be envisaged for enhancing the application of those markers of success? How can they be replicated and scaled up?
- 3. What possible commitments could you envisage for your country or organization to enter into the Water Action Agenda?

14:30 – 16:00 Workshop 2: Water and Disaster Risk Reduction

The last twenty years have seen a sustained rise of frequency and intensity of disasters, water-related disasters in particular. Climate change, an important disaster risk driver, affects water availability and demand, exacerbating water scarcity, as well as increasing the frequency and intensity of water-related disasters. Given the important water use of many sectors - agriculture, energy, industry etc. - addressing water-related systemic risks is critical for a resilient and sustainable society. This requires coherent and systemic risk governance across sectors at all levels, including prevention, preparedness and sustainable use of available resources as well as robust multi-hazard early warning and response systems reaching the 'last mile'. Reliable data are further crucial for risk-informed and evidence-based policies as well as for integrated water resources management. The coinciding midterm reviews of the Sendai Framework for Disaster Risk Reduction and the Water Action Decade in 2023 offer a unique opportunity to identify adjustments that promote risk-informed development while sustainably managing water resources and associated ecosystems.

The second workshop, with the support of **UNDRR**, will showcase the role of Geneva-based organisations in promoting data, science, technology and capacity building for achieving SDG 6 and other related goals and targets and propose solutions to accelerate actions, including by leveraging the coinciding midterm reviews.

Objectives of this workshop:

1. Highlight the work of Geneva-based organisations in promoting data, science, technology, capacity building and other solutions for achieving SDG 6 and other related goals/targets, in particular SDG 1 (no poverty), SDG 11 (sustainable cities and communities) and SDG 13 (climate action)

- 2. Identify gaps and opportunities to accelerate action in achieving SDG 6 and addressing water-related disaster risks towards 2030
- 3. Explore options to leverage the coinciding midterm reviews of the Sendai Framework and the Water Action Decade for risk-informed sustainable development.

Guiding questions for participants:

- 1. In your experience, what have been the major bottlenecks in advancing SDG 6 and addressing water-related disaster risks and how will your country or organization tackle these in the future?
- 2. Given the systemic nature of risk, what adjustments are needed to enhance water-related disaster and climate risk governance? Which role can for example increased public and private investment in disaster risk reduction play as part of the solution?
- 3. What type of voluntary commitments would accelerate the integration of risk-informed development considerations into the second half of the Water Action Decade as contributing to the Water Action Decade?

Participants are invited to participate in the <u>survey that is seeking to collect inputs from the</u> <u>water community</u> to the <u>Midterm Review of the Sendai Framework</u>. The is a great opportunity to share experiences and recommendations for potential policy adjustments and new modalities for implementation of the Sendai Framework for the period between 2023 and 2030 with a view to accelerating risk-informed regenerative and sustainable development.
